5. Consumer Consent, Attestation and Release

a. Consent

I hereby authorize Clean Nova Scotia Foundation, in its capacity as the Program Administrator of the Electrify Nova Scotia Rebate Program (the "Program"), to:

1. collect the personal information included in this application and supporting documents;
2. store the personal information as set out below;
3. use the personal information for the purposes of delivering the Program as described and for the purposes outlined below; and
4. disclose the personal information to the provided to Her Majesty the Queen in Right of Nova Scotia, in its capacity as the funder of the Program, and as represented by the Minister of Energy & Mines.

This information is being collected by the Program Administrator and will be shared with the Minister of Energy & Mines and/or their delegated employees for the purpose of:

1. administering the Program, which includes but is not limited to determining the eligibility for a rebate under the Program and evaluating the Program including informing future program policy related to electric vehicles; and
2. validating the eligibility of products and consumers, which involves reviewing such information as the vehicle identification number, date of birth and postal code of the purchaser / lessee.

The personal information collected will be shared only with those employees of the Program Administrator and the Department of Energy & Mines as is reasonably required for the administration and evaluation of the Program. Under the provisions of the *Freedom of Information and Protection of Privacy Act*, individuals have the right of access to, correction of and protection of their personal information. b. Attestation

I attest that I have not already applied for or received the same class of rebate (i.e., new electric vehicle, used electric vehicle or e-bike) under the Program during this calendar year, other than for the purchase or lease for which this form is completed.

I represent that I will not seek to receive more than one of the same class of rebate under the Program in any calendar year. I understand that should I be found to have received more than one class of rebate from the Program in a calendar year, the Program Administrator may seek to recover the amount of the rebate provided to me.

Your telephone number and email address allow us to communicate with you to obtain, if need be, additional information essential to process your application or evaluate the Program. Your home mailing address is required so we can mail the rebate cheque. (Note that we will not mail rebate cheques to addresses outside of Nova Scotia.)

I understand that if I do not meet all the conditions and terms set out in the Program guidelines (available at electrifyns.ca) the application review process may be delayed, or my application may be deemed ineligible for the rebate.

I acknowledge that the Program Administrator may ask that the rebate be repaid in the event of false declaration, and that this may further disentitle me from eligibility for future rebates.

I hereby declare that I have read and understood all the conditions and terms set out in the Program guidelines, along with the declarations and consents indicated earlier.

I declare that the information provided in or in respect of this application is **true** and **complete**.

c. Release

I hereby release Clean Nova Scotia Foundation and Her Majesty the Queen in right of Nova Scotia, their agents, officers, employees, contractors, successors, and assigns from any claims, liability, damages, action or causes of action arising from or relating to the information and its use.
