Consumer Consent

I further consent and authorize the Program Administrator to:

1. collect my personal information provided to the dealership;
2. store the personal information as set out below;
3. use the personal information provided to the participating dealership for the purposes of receiving the provincial electric vehicle rebate under the Program, as described and for the purposes outlined below; and
4. disclose the personal information to the Minister of Natural Resources and Renewables for the purposes outlined out below.

This information is being collected by the Program Administrator and will be shared with the Minister of Natural Resources and Renewables and/or their delegated employees for the purpose for the purpose of:

1. administering the Program, which includes but is not limited to determining the eligibility for a rebate under the Program and evaluating the Program including informing future program policy related to electric vehicles; and
2. validating eligible electric vehicle purchases, which involves reviewing the vehicle identification number and the date of birth and postal code of the purchaser / lessee.

The personal information collected will be shared only with those employees of the Program Administrator and the Department of Natural Resources and Renewables as is reasonably required for the administration and evaluation of the Program. Under the provisions of the *Freedom of Information and Protection of Privacy Act*, individuals have the right of access to, correction of and protection of their personal information.
